



# URGENT: Update to Disaster Declaration issued for Hurricanes Marco and Laura

## Action Now:

Per the [Texas Health and Human Service Commission \(HHSC\)](#), Governor Greg Abbott issued a Disaster Declaration for Hurricanes Marco and Laura, for the following counties of Jackson, Grimes, Leon, Madison, and Travis Counties. These storms pose a threat of imminent disaster, including widespread and severe property damage, injury, and loss of life due to widespread flooding, storm surge, and damaging winds in our service areas of Jackson, Grimes, Leon, Madison, and Travis Counties.

## What does this mean?

The Governor authorized the use of all available resources of state government and political subdivisions to cope with the declaration of a state of disaster for the county and zip codes listed below exist.

Any state statute or administrative rule that would impede state agency's emergency response; which is necessary to protect life or property threatened by this disaster, is suspended during the declared disaster.
